Far West Cowboy Dressage Gathering

We are so excited to be bringing Cowboy Dressage back to Central Oregon! Thank you for joining us. Below is some important information about the show.

FOOD: The Rim Rock Riders Event Center has an on-site café, which will offer breakfast, lunch, and dinner.

SATURDAY EVENING FISH DINNER: Kelley Rankin from Little Bear Creek Farm will kindly be providing fresh-caught fish! Rim Rock Riders Café will be preparing the fish and the side dishes. Cost will be \$20 per person (to cover the cost of the fish preparation and the side dishes). Beer and wine will be available for purchase from the Rim Rock Riders Café.

SUNDAY CELEBRATION AND AWARD CEREMONY: On Sunday afternoon, while High Score Awards are being calculated, the horse show management will be providing complimentary cake and live music. Rim Rock Riders Café will be serving nachos for \$10 per plate during this time.

SILENT AUCTION: Please bring any silent auction contribution you would like to make to the office. Bidding for the silent auction will conclude at 2pm on Sunday and will be announced at the Sunday Celebration. The Silent Auction proceeds will fund future Cowboy Dressage horse shows.

FREESTYLE: The Freestyle will be held after the other classes on Friday, June 3rd. Freestyle music needs to be formatted as mp3, copied onto a labeled USB flash drive, and be presented to Office for sound check by 5:00 p.m. Thursday, June 1st. Please have note of instruction as to when music is to begin. Only one song and one rider on the thumb drive.

SCHOOLING: The show arenas will be open at 8am on Thursday, June 1st for schooling. Please do not enter the arenas before this time, as our contract with Rim Riders Event Center does not include use of the arenas prior to 8am on Thursday. Arenas will also be available before and after the show each day for schooling. Each arena will be closed for tractor maintenance for approximately two hours each evening.

EARLY STABLING CHECK-IN: 5:00 PM Wednesday, June 1. Please, no arrivals before then. Stalls will have name cards.

REGULAR STABLING CHECK-IN: 12:00 PM Thursday, June 2. Stalls will have name cards.

STABLING CHECK-OUT: 8:00 PM Sunday, June 4, unless you have already paid for a Sunday night stall. If a Sunday night stay is needed but not reserved, please see the office for a Sunday night reservation.

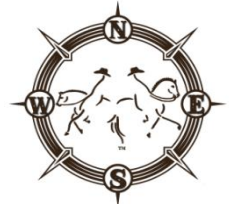

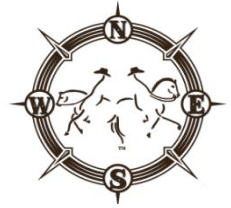

High Score Calculations and Eligibility

TEST DIVISIONS

- Walk/Jog*
- Walk/Jog/Lope*
- Challenge*
- Gaited*
- Vaquero Buckaroo*
- Partnership
- Freestyle
- Liberty

*Classes from these divisions are eligible for high score calculations.

RIDER STATUS DEFINITION

- Open: Rider that is 18 years or older, who makes a living or receives income from training, teaching lessons or clinics.
- Amateur: Nonprofessional rider that is 18 years or older.
- Junior: 17 and under (An individual who has not reached his/her 18th birthday as of January 1st of the current competition year). On show grounds, juniors are not allowed to handle/ride stallions and must wear a helmet when working with a horse at any time (not just while showing).

HIGH SCORE AWARDS:

- Class Placing: Classes will be placed to 10th, and ribbons will be awarded to 5th.
- High Score: Awarded to the highest average scoring rider/horse combination in Open, Amateur, and Junior. In order to be eligible, a rider/horse combination must show in a minimum of 5 classes at the show in any of the eligible classes (Partnership, Freestyle, and Liberty classes are not eligible). For calculations, the highest 5 scored tests will be added together, and then divided by 5. Reserve high average score to be awarded as well, using the same method of calculation. Ties will be broken by highest single soft feel score.
- Division High Score: Awarded to the highest average of 5 scores, regardless of status (must show in a minimum of 5 classes in the division). Divisions are Walk/Jog, Walk/Jog/Lope, Challenge, Gaited, Vaquero Buckaroo, Partnership, Freestyle, and Liberty. Ties will be broken by highest single soft feel score.
- Soft Feel: Awarded to the highest soft feel score in Open, Amateur, and Junior (Partnership and Freestyle classes are not eligible). Ties will be broken by highest-scored test.



Honorary Awards

- Rookie High Score: Amateur Rider in first year of showing.
- Silver High Score: 65+ year-old Amateur Rider.
- Platinum High Score: Amateur Rider and their horse whose ages add up to 90 or above.
- Veteran High Score: Any US veteran or anyone wishing to ride in honor of a US veteran is eligible. Award is given to any individual one time per year only.
- Cancer High Score: Any cancer survivor, anyone battling cancer, or anyone wishing to ride in honor of someone who has faced cancer, may enter. This award is given to any individual one time per year only.
- Jack Brainard Judge's "Try" Award: For the most improved rider for the duration of the show. To calculate this award, each judge identifies a horse and rider combination that showed marked improvement with each ride.

Other Information to Consider

Callers: The riders are encouraged to memorize their tests. The use of a caller is not mandatory. Riders may use a caller of their choice; however, the ultimate responsibility for accurate and correct riding of the test falls upon the rider. We highly recommend that the caller practice with the rider beforehand in order to provide a flawless test call on the day of the show. If the rider chooses to use a caller, it is the rider's responsibility to arrange for one.

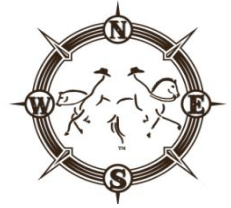
A Note About Gaited Horses: The gaited tests are designed specifically for the gaited horse. Gaited horses are welcome in the non-gaited tests but will be scored a maximum high value of 4.5 if gaiting instead of jogging when requested in the non-gaited test.

Maximum Tests per Day: A maximum of 4 under saddle tests will be permitted per horse per day. A maximum of 4 on the ground tests will be permitted per horse per day. For those who choose to ride in the freestyle, the freestyle **will count toward** the 4-maximum allowed under saddle classes for each horse on Friday.

Age of the Horse: The Cowboy Dressage Horses' age is based on January 1st of that calendar year, regardless of the month foaled. For example - a horse foaled anytime in the year 2010 is considered one-year-old on January 1, 2011, and two years old on January 1, 2012.

REMEMBER: The Cowboy Dressage World Partners want its members to consider the age and performance level (of both horse and rider) when choosing test levels.

Cancellations and Refund Policy

There will be no refunds for scratched tests after the entry closing date (5/12/23).

We encourage these options to cancellation in the event the horse is unable to perform as planned:

- Classes entered may be revised until May 25
- Horse entered may be changed until May 25.

Partial refund may be granted as follows:

Any request for cancellation or refund must be submitted in writing, preferably email. Please include a veterinarian's statement if applicable.

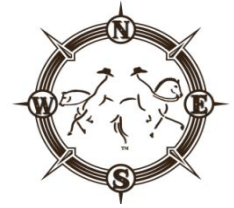
- Request for refund will be reviewed and approved after the event by a third party.
- Timing will play a part in approval of many fees as filling vacated entries will be considered in the refund review.

Any approved refunds will be processed within 30 days after the event.

- Once entry has been processed, there will be no refund of office fees, late entry fees or Cowboy Dressage World nonmember fees.
- Class entry fees will not be eligible for refund unless there is a valid medical/veterinary condition, and/or the vacated class spot can be filled.
- Stall fees or haul-in fees may be refunded if horse is not on show grounds.
- Camping fees may be refunded if not used.

General Rules and Regulations

EVERY CLASS OFFERED HEREIN IS COVERED BY THE RULES AND SPECIFICATIONS DESIGNED BY COWBOY DRESSAGE WORLD, ALL OF WHICH CAN BE FOUND AT www.cowboydressageworld.com AND WILL BE CONDUCTED AND JUDGED IN ACCORDANCE HEREWITH.

Rules and regulations “responsibilities”: The OWNERS, RIDERS, AND TRAINERS are responsible for the knowledge of and compliance with the rules of Cowboy Dressage.

Other Rules and Regulations:

- Entries must be paid in full by entry closing date. Any unpaid entries will not receive a number.
- Entries must be made on the form provided herein, fully completed, with all required signatures, and accompanied by a check or money order in the full amount, payable to “High Desert Equine Events”. Any unpaid entry shall not be recorded. All entries postmarked after closing date will be considered post entries and post entry charges collected.
- Exhibitors are responsible for their own errors and those of their agents in preparation of entry blanks.
- All horses brought into the grounds must be registered at the Show Office and given a number. Horses are required to display their number when being ridden on show grounds (except on Thursday).
- Schooling horses are allowed. Horses brought to the show to school are required to be registered through the office and a release signed. Mandatory office fees apply per horse.
- Management reserves the right to change or alter the officials listed without notice prior to or during the show.
- Show Office is to be advised before the class of 'scratches' of horse or rider at least one hour before ride time as a courtesy to other competitors and the Show Office. Any class change may be done on a case-by-case basis, as long as it does not disrupt ride times. No changing of classes at arena.
- A maximum of 4 under saddle tests will be permitted per horse per day. A maximum of 4 on the ground tests will be permitted per horse per day. For those who choose to ride in the freestyle, the freestyle **will count toward** the 4-maximum allowed under saddle classes for each horse on Friday.
- Stalls will be assigned by Horse Show Management and will be available on Wednesday, June 1 at 5:00 p.m. Exhibitors may identify on their entry forms who they would like to be stabled next to but requests for specific stalls will not be considered. Exhibitors will be billed for the cost of repairing any damage to any stalls they use. Any stall used, regardless of reason, shall be subject to the regular stall fee. Only management may reassign stalls. Reassignment may be necessary if an exhibitor cancels after stall assignments have been made or does not use all stalls assigned. Failure to abide by management’s stabling assignments may result in an exhibitor being prohibited from competing.
- Rim Rock Riders Event Center does not permit outside shavings to be used on show grounds. Please do not bring your own shavings. Shavings can be purchased on the entry form and through the Show Office.
- Arenas will be open at 8am on Thursday, June 1st for schooling. Please do not enter the arenas before this time, as the contract with Rim Riders Event Center does not include use of the arenas prior to 8am on Thursday.
- Only assigned cars, trucks and/or trailers will be allowed to park in main barn area, as approved by Show Management. This will be strictly enforced. 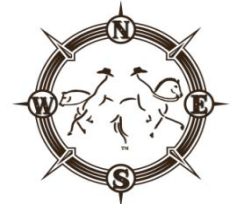
